V. Review:

- a. Head Tax Motion passed unanimously –  
**“\$1.00 head tax per athlete competing in a sanctioned event involving Xcel or Developmental Program in the state of Indiana. The head tax shall be paid via a check payable to Indiana USA Gymnastics.”**
- b. ISQ Definition motioned passed unanimously –  
**“Indiana State Qualifier is defined as any sanctioned competition in the state of Indiana that has been approved by the Indiana State Administrative Committee and that is hosted by a USA Gymnastics member club located in the state of Indiana. Said club must also be in good standing with Indiana USAG.”**

- c. Compulsory State Qualification score **deadline extended until February 27, 2023.**
  - i. *The reservation deadline will remain February 20, 2023. This ensures meet directors can create a rotation schedule and published it to the community in a timely manner.*
  - ii. *Clubs that register athletes after the reservation deadline will incur a late fee of \$25.00 per late entry (athlete).*

##### ii. Indiana Judges selected for Region 5 Regional Meet expectations

1. ***“If you are selected to judge a regional or above competition you are expected to be available for Indiana State meet in the respective area. Judging Regionals does not guarantee you a state meet assignment. There may arise a situation where Indiana sends more judges to Regionals than are available at the state meet.”***

##### iii. State Meet Judging Alternates

1. Michelle motions to **“add the state meet 1st alternate judge to the competition. The Judge’s travel and hotel will be part of the host clubs responsibilities. The alternate will be expected to attend the meet and practice judge at least one session of every level at the competition.”**

#### b. Priority System Discussion

- i. **A separate bid form will be created for each priority level.** This will make it easier for the clubs to bid and the committee to view each bid.
