- c. Topic 3: State Qualification Score
 - i. Compulsory Qualification score achievement deadline will be one week later than in previous years. This will allow athletes one more weekend to achieve the Q-score. February 27, 2023 is the 2022-2023 Compulsory State meet qualification score deadline.
 - ii. Compulsory State Meet reservation deadline will remain three weeks prior to the Compulsory State Meet. February 20, 2023 is the 2022-2023 Compulsory State meet registration deadline.
 - iii. Clubs will still have to register before February 20, 2023. Any registrants that happen after the 20th will incur a late fee of \$25.00 per athlete.

 - i. Create wording that qualifies judges to judge the state meet.
 - 1. How are we ranking our judges for the regional committee.
 - 2. Create a system that can be public, explained, and repeatable
 - ii. Bring in the judging assigners to the judges ranking meeting.
